LinAqua forte, solution for the mouth and throat irrigation. Hypertonic concentration, for children and adults

Description and composition

LinAqua forte is odorless and colorless solution for nasal cavity irrigation.

Natural sea water contains sodium chloride (NaCl) of 21 g/l (hypertonic concentration).

Contains all active substances and trace elements of sea water: K, Mg, Na, Ca, Cl, Se, I, Zn, Cu, Fe, etc. Does not contain preservatives.

Therapeutic indications

Otorhinolaryngology. The solution is intended for everyday hygiene of mouth and throat mucous membranes and as a part of complex treatment of ENT diseases for children from 2 years and adults.

Properties

Solution provides moisturizing effect, relieves irritation of mouth and throat mucous membranes.

Helps to mend the discomfort in a dry, sore and scratchy throat caused by respiratory diseases.

Reinforces the resistance of the mouth and throat mucous membrane to pathogenic bacteria and viruses, boosts local immunity.

Helps to increase the therapeutic efficacy of medications applied in the oral cavity and reduces the duration of respiratory diseases.

Washes away dust, smoke and the other pollutants preventing them from entering lungs.

Indications for use

Product is indicated for children from 2 years and adults.

- daily use as a part of complex treatment of acute and chronic, infectious and inflammatory diseases of the throat: tonsillitis, adenoiditis, pharyngitis, laryngitis;

- for the prevention and comprehensive treatment of acute respiratory viral infections;

- to prepare the oral cavity for medications use;

- for patients who has dry mucous membranes of posterior pharyngeal wall which is caused by increased dryness or air pollution (central heating, air conditioning). Solution helps to preserve physiological characteristics of the mucous membrane of the throat in altered microclimatic conditions.

Contraindications for use

Individual intolerance to the components of the solution.

If in doubt consult your doctor or ENT specialist.

Precautions for use

Inspect the packaging and product before use. Do not use the product if the packaging is damaged.

Avoid contact with eyes.

Possible side effects

No side effects have been reported.

Interactions with other medicinal products and medical devices

Can be combined with all medical products and physiotherapeutic procedures.

Recommended dosage

3-4 sprays on the back of the throat 4-6 times a day.

The duration and frequency of use of the product is not limited.

Special precautions

If you are pregnant or breastfeeding consult your healthcare specialist before use.

It does not interfere with the ability to drive or use machinery.

Requirements for use

The product is for individual use only. Using at home does not require special training and special skills.

Contents of the pack

Aerosol bottle (volume of 50 ml, 100 ml, 125 ml, 150 ml or 200 ml) with a nozzle for mouth and throat.

Shelf life

3 years. Do not use after expiration date.
